- ♦The buyer becomes significantly ill, either physically or mentally, for a period of 3 months; documentation is required by physician.

- ♦The buyer or estate is also entitled to a prorated refund in the case of his/her death.

Emails: Longfellow New Hampshire does not sell or share your email address with any third parties. Your email address is used to communicate special events, our monthly newsletter, snow closings, changes in class schedules, as well as any other information we feel may be of importance to you.

The following are a few club rules we feel need special attention. Club rules are not limited to these and are subject to change.
